Fees and payment terms 2026-2027

Registration Fee (Annual Fee)

The annual Registration Fee is CHF 1'045 for the 2026-2027 academic year and covers all administrative costs of processing admissions. The Registration Fee is payable at the time of enrolment and re-enrolment and is non-refundable.

Capital Development Fee (One-off Fee)

The CHF 3,000 Capital Development Fee is allocated to the continuous maintenance and enhancement of the learning environment. The Capital Development Fee is a one-off fee applicable only during the student's first year of enrolment and is non-refundable. For children arriving during the course of the academic year, the Capital Development Fee and the Registration Fee are payable in full and both are non-refundable. In all cases the Capital Development Fee and the Registration Fee apply.

Standard Payment Terms

Annual Tuition Fees are divided into three instalments in order to spread the cost for parents. The three instalments are due before 1st August, 1st December and 1st April, respectively
